Next priorities (Tangier Declaration)

Invest on good management

- Reinforce fully and strongly protected areas (no-go, no-take, no-fishing zones) and create new MPAs in the Open Sea
- Provide long-term resources for MPA management at local level (sufficient human, material and financial)
- Ensure long-term MPA capacity-building and networking at Mediterranean level











Next priorities

Healthy Seas as driver for economies


- Create win-win relationships of MPAs with decisionmakers, donors and private sector to respond pressures beyond MPA borders
- Consider MPAs as main tool to protect natural capital to reach sustainability targets
- Develop the role of MPAs as a marine spatial management tool in supporting ecosystem-based adaptation and mitigation to climate change














Creation of an MPA marine turtle group in the Mediterranean





Inception of the MPA Marine turtle group

- Origins: 2014 MedPAN's workshop on management monitoring
- MPA forum roadmap and MedPAN 2018-2023 strategy about expert groups
- First meeting in 2017 during a MedPAN exchange visit in Zakynthos
- Objective of this 1st meeting: lay the foundations of an MPA marine turtles group captained by the MPA managers themselves to directly answer their needs.









Composition of the group

Group mainly composed of MPA managers (blue dots)
But also of scientists and NGOs (green dots).







Objective of the group



Strengthen collaboration among the Mediterranean marine turtle community to better address the challenges of the conservation of marine turtles and support an integrated management strategy for these species:

- Exchanges of knowledge and expertise to propose solutions to address management issues,
- monitoring and adaptive management,
- Peer-to-peer exchanges to support newly created or future MPAs,
- Training sessions (for satellite tracking, drone monitoring, tagging...),
- Sharing of information for an integrated management,
- Advocacy activities towards decision-makers (have more weight as a group),
- Contribute to the development of a common database,
- Enhancement of the collaboration between stakeholders (scientists, managers, fishermen, local communities...),
- Development of sub-groups for specific issues regarding marine turtles conservation (e.g. stranding network).





Initial activities in the framework of the MAVA project

- MedPAN is part of the large MAVA foundation project "Conservation of marine turtles in the Mediterranean region" 2017/2022 (1.35 M. €)
- Partners involved: SPA/RAC, ARCHELON,
 DEKAMER, MEDASSET, MedPAN, National Marine
 Park of Zakynthos, WWF Greece and WWF Turkey.
- Objective: reduce or eliminate human induced direct mortality of marine turtles in the Mediterranean
- 5 axes
 - research and monitoring,
 - reinforced coordination,
 - capacity building,
 - improved management/protection of nesting sites and adaptive management in nesting, wintering and feeding sites
 - reduction of illegal trade.

MedPAN Work in progress

- Development of methodological guide for the monitoring of marine turtles.
 - The guide aims to promote the use of harmonised and standardised MPA monitoring protocols at a regional level to facilitate the sharing, analysis, comparison of data
- Development of a cooperation framework for the monitoring of marine turtles to facilitate data sharing.
 - The charter aims to define clear rules regarding the use, dissemination and publication of shared data.
